Personal precautions, protective equipment and emergency procedures

Precautions for safe handling

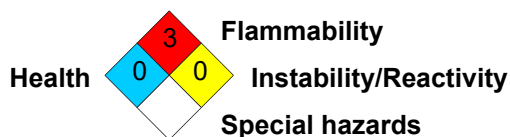
