Section 5. Fire-fighting measures

Extinguishing media

Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

Small spill : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Dispose of via a licensed waste disposal contractor.

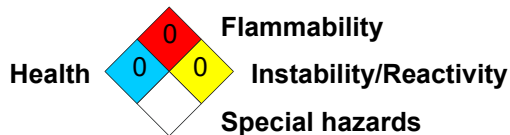
